Keep Ulmer on S.F. bench

Neither of the challengers to San Francisco Superior Court Judge Richard Ulmer offers a convincing rationale for his ouster. They cannot cite any flaws with his credentials, his temperament nor his rulings from the bench.

Both Michael Nava and Dan Dean present themselves as accomplished attorneys with deep community roots and aspirations to reach the judiciary. Both have also suggested diversity should be a consideration: The challengers are gay, Ulmer is not.

Nine of the 51 San Francisco judges are gays or lesbians - and all have endorsed Ulmer.

Before being appointed to the bench by Gov. Arnold Schwarzenegger, Ulmer had a distinguished legal career that included a lead role in forcing the state to improve prison conditions at the California Youth Authority. His challengers have not made a compelling case to remove a judge with impeccable credentials who emerged through the rigorous state appointment process.
